- Map of facilities and other infrastructure to be installed in Concession Area;
- Summary of health and safety risks and preventive measures as set forth in Article 86 and other Applicable Law.
- Summary of the environmental management plan and monitoring program, pursuant to this Code and other Applicable Law;
- Details of the Development work to be carried out and estimated duration thereof;
- The management and operations structure including workforce and procurement strategy aimed at using Timor-Leste Goods and Timor-Leste Services, according to this Code;
- Mine closure plan; and
- Other requirements provided for the development of the Mineral Deposits in accordance with Good Mining Industry Practice.
